| May 15, 2023 | - Last day to file written objections to Independent Nominating Petitions (Election Law § 15-108(10) – not later than 1 day after the last day to file the petition). Since this day falls on a Sunday it will be accepted on the next business day which is Monday |
| May 15, 2023 | - Last day to file certificate of acceptance or declination of Independent Nominating Petitions (Election Law § 15-108(8)(b) – not later than 3 days after the last day to file petition) |
| May 17, 2023 | - Last day to file written specifications of objection to Independent Nominating Petitions (Election Law § 15-108(10) – within 2 days after the filing of the written objection) |
| May 17, 2023 | - Filing of First Statement of Campaign Receipts (Rules of the State Board of Election §§ 6200.1 & 6200.2 – must be 32 days before the election) |
| May 19, 2023 | - Last day to file a certificate to fill vacancy caused by declination of Independent Nominating Petitions |

(Election Law § 15-108(8)(c) – not later than 3 days after the last day to file a certificate of declination)

| June 6, 2023 | - Last day to file second statement of campaign receipts (Rules of the State Board of Election §§ 6200.1 & 6200.2 – must be 11 days before the election) |

| June 7, 2023 | - Last day individuals may register with the County Board of Elections (Election Law § 15-118(2) – at least 10 days before the election) |
| June 9, 2023 | - Last day for Village Clerk to receive applications for absentee ballots to be mailed (Election Law §15-120(4) – at least 7 days prior to the election) as 7 days would be a Saturday, this date is for the Friday before |
| June 9, 2023 | - Last day for Village Clerk to mail absentee ballots (Election Law §15-120(5) – at least 6 days prior to the election) as 6 days would be a Sunday, this date is for the Friday before |
| June 15, 2023 | - Last day for Village Clerk to receive personal applications for an absentee ballot from applicant or applicant's agent. Upon receipt of application, clerk must deliver absentee ballot to applicant or agent (Election Law §15-120(5) – no later than 1 day prior to the election) |
| June 16, 2023 | - Last day for Village Clerk to accept absentee ballot |
| June 16, 2023 | - Village Election Day |
| July 13, 2023 | - Third Filing of Campaign Receipts (Rules of the State Board of Election §§ 6200.1 & 6200.2 – must be 27 days after the election) |
