VILLAGE ELECTION

If any days fall on a holiday or weekend, the filing day will be the next business day

- February 20, 2025 - First Day Village Clerk may accept absentee ballot applications
(*Election Law § 15-120(5) – not earlier than 4 months prior to election*)
- February 20, 2025 - First Day Village Clerk may accept early mail ballot applications
(*Election Law § 15-119(7) – not earlier than 4 months prior to election*)
- April 4, 2025 - First Day to file a petition to cause a permissive referendum to appear on
general election ballot
(*Village Law § 9-902(6) – If such petition is filed on or after the first day
of the month two months prior to the month in which the general village
election is to be held and on or before the first day of the month in which
the general village election is to be held, a proposition for the approval of
such act or resolution must be submitted at the general village election.*)
- April 4, 2025 - First Day that individuals may sign independent nominating petitions
(*Election Law § 15-108(9) – not earlier than 6 weeks before the last day to
file independent nominating petition*)
- May 9, 2025 - First Day to file an independent nominating petition
(*Election Law § 15-108(8)(a) – not earlier than 42 days prior to election*)
- May 16, 2025 - Last day to file an Independent Nominating petitions
(*Election Law § 15-108(8) (a) – not later than 35 days prior to election*)
- May 17, 2025 - Last day to file written objections to Independent Nominating
Petitions
(*Election Law § 15-108(10)(d) – not later than 1 day after the last day to
file the petition.*)
- May 18, 2025 - Last day to file written specifications of objection to Independent
Nominating Petitions
(*Election Law § 15-108(10) – within 2 days after the filing of the written
objection*)
- May 19, 2025 - Last day to file certificate of acceptance or declination of
Independent Nominating Petitions
(*Election Law § 15-108(8)(b) – not later than 3 days after the last day to
file petition*)
- May 19, 2025 - Filing of First Statement of Campaign Receipts
(*Rules of the State Board of Election §§ 6200.1 & 6200.2 – must be 32
days before the election*)

- May 22, 2025 - Last day to file a certificate to fill vacancy caused by declination of Independent Nominating Petitions
(Election Law § 15-108(8)(c) – not later than 3 days after the last day to file a certificate of declination)
- June 1, 2025 -Last day to file petition to cause a permissive referendum to appear on the general election ballot
(Village Law § 9-902(6) – If such petition is filed on or after the first day of the month two months prior to the month in which the general village election is to be held and on or before the first day of the month in which the general village election is to be held, a proposition for the approval of such act or resolution must be submitted at the general village election)
- June 9, 2025 - Last day to file second statement of campaign receipts
(Rules of the State Board of Election §§ 6200.1 & 6200.2 – must be 11 days before the election)
- June 10, 2025 - Last day individuals may register with the County Board of Elections
(Election Law § 15-118(2) – at least 10 days before the election)
- June 13, 2025 - Last day for Village Clerk to receive applications for absentee ballots to be mailed
(Election Law §15-120(5) – at least 7 days prior to the election)
- June 13, 2025 -Last day for Village Clerk to receive applications for early mail ballots to be mailed
(Election Law §15-119(7) – at least 7 days prior to election)
- June 14, 2025 - Last day for Village Clerk to mail absentee ballots
(Election Law §15-120(6) – Not later than 6 days prior to the election)
- June 14, 2025 - Last day for Village Clerk to mail early mail ballots
(Election Law §15-119(8)) – Not later than 6 days prior to the election)
- June 19, 2025 - Last day for Village Clerk to receive personal applications for an absentee ballot from applicant or applicant’s agent. Upon receipt of application, clerk must deliver absentee ballot to applicant or agent
(Election Law §15-120(5) – no later than 1 day prior to the election)
- June 19, 2025 -Last day for Village Clerk to receive personal applications for an early mail ballot from applicant or applicant’s agent. Upon receiving application, clerk must deliver the early mail ballot to the applicant or agent if (1) application is complete (2) applicant is a registered voter of the Village at the address listed in the application, and (3) the applicant is eligible to vote in the election
(Election Law 15-119(7) – Not later than 1 day prior to the election)
- June 20, 2025 - Village Election Day

- June 20, 2025 - Last day for Village Clerk to accept absentee ballots and early mail ballots in person or by mail
- June 22, 2025 - Last day for Village Clerk, upon his or her own volition or upon the written request of any candidate, cause a recanvass of the vote cast (*Election Law §15-126(3) – not later than 2 days after the date of the election*)
- June 23, 2025 - Deadline which Village Clerk must notify the county board of elections of the request for recanvass (*Election Law §15-126(3) – within 1 day after receiving the written request*)
- June 23, 2025 - Last day for Village Clerk to notify successful candidates that they have been elected and must take an oath of office within 30 days after they take office (*Election Law §15-128 – within 3 days after the election*)
- July 17, 2025 - Third Filing of Campaign Receipts (*Rules of the State Board of Election §§ 6200.1 & 6200.2 – must be 27 days after the election*)
- August 6, 2025 -Deadline for elected official to file their written oath of office with the Village Clerk (*Public Officers Law §§ 10 and 30 – Within 30 days of the commencement of term of office*)
